Zoom or in the Room?

Post Pandemic Meeting Choices Loom...

It all began with a request from our District 22 Committee Member (DCM) for an Ad hoc Committee to investigate the possibility of modifying our monthly GSR meeting from Zoom (online only) into a hybrid meeting (same meeting both online **and** in person), when the county met the qualifications to resume indoor gatherings. I volunteered to chair the committee, having an interest in the subject. I work at a local Community College, and we are facing a similar situation with our Fall semester class offerings.

The first thing I did was to recruit a GSR from Morro Bay and our Grapevine Rep from Paso Robles to join the committee. They were both involved to some extent in their own fledgling hybrid meetings. Their evolving reports of environmental, physical, and technological issues revealed that this was a multi-faceted research project with no simple solution.

But wait... there were the **Hybrid Pioneers**! I knew there were a few meeting places that had been holding hybrid meetings for months already. I had gone to a couple monthly Birthday meetings on zoom and some attendees were actually sitting *in the room* on Higuera in SLO! I had had a similar experience at a Five Cities Group meeting! People were in the room, occupying one square of my zoom meeting's Brady Box! As you can tell by the number of exclamation points, I found this to be some pretty exciting stuff.

Speaking of the "Melody" group, they have a sister group named "Harmony" which consists of... **online meetings only!** At the college we would call this an "asynchronous hybrid" as opposed to a "synchronous hybrid".

Synchronous is where the attendees are at the same meeting in Zoom <u>and</u> in the Room (1 meeting, 2 venues), and asynchronous refers to attendees in separate meetings in Zoom <u>or</u> in the Room. So, we are talking *synchronous* when we say "Hybrid". Clear as mud? What happened to SIMPLE program???

To give an example of just a few of the differences involved, our two committee members' hybrids are worlds apart. The one in North County is in a park (e.g., outdoors). The technology is a cell phone and a laptop. The issues are mostly weather related... glare from the sun on the screens and camera, wind messing with the audio, the need to pass the phone around to be able to share with the zoomers and be heard... crazy, man! The laptop is used so the zoomers can see and be virtually a part of the park setting. Some of us will go to ANY LENGTHS to carry the message to the still suffering alcoholic!

The coastal hybrid is in a meeting hall. To keep anonymity for those who desire it, there is a podium audio/video booth for the secretary and the speaker(s) which allows the rest of the roomers to be off camera. At least that is my understanding, I must admit that I have not participated in any of these meetings yet. But I will!

I have much more to report to you as I have more research to do and some experiments of my own to try. I would like to request that any of you reading this and having any experience with the hybrid meeting format please contact me at NNLeditor@sloaa.org If you know anyone who has this type of knowledge, could you let them know? I'd love to talk to them also.
